Tertiary grant applications for 2023 are currently being reviewed. Numbers of student applications increased by 30% from 101 last year to 132 this year. In many cases, additional funding is also made available through JV arrangements with Māori Education Trust.

An increased number of applications were received this year for Haane Manahi Scholarship, and these are also currently under review by the Committee. These scholarships are to support Trades and Apprentices and will open again next year.

The Board has recently reviewed their policy for Nga Mahi a Rehia grants, resulting in increased funding being made available to assist school teams competing in Regional and National kapa haka competitions. Further information will be available on our website shortly.


