Since our last update, we are pleased to welcome the following to our sites:

Trade Central:

We are well underway in the refurbishment of the former Trade Training Unit which, when completed, will accommodate Lakeland Mowers & Chainsaws Limited in the eastern end of the building and a “new to town” retailer in the western end.

We also look forward to welcoming another new to town business in the tenancies along the front of Kmart with negotiations under way on two of the three remaining tenancies.

Rotorua Central:

With the relocation of Van Dyks and Flooring Xtra, plans are under way to establishing 3-4 new tenancies within this space.

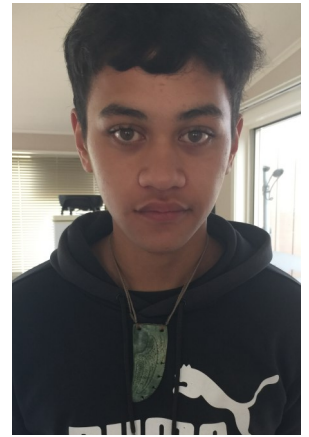

Te Kotahitanga o Ngāti Whakaue Assets Trust



Tēnā rā tātau Ngāti Whakaue

At the start of the month we had another outbreak of COVID-19 in Auckland, putting Auckland into Alert Level 3 and the rest of the motu into Level 2. This is the second outbreak in 2021 and is a reminder of the ongoing threat COVID poses. It has also meant that we had to postpone Whakaue Whānau Day again, out to the end of the year! We had planned an exciting day of kai, stalls, live performances, and tours through the forest / nehenehe, all run by Whakaue. On a positive note, we were able to create an event management internship for one of our Whakaue whanaunga, giving them great on-the-job experience.

In December and January our Distributions Manager (Kaitaurima Tohanga Hua), Tatiana held multiple hui with our kaumātua to better understand their wellbeing needs and help inform the Trust's thinking around how it can provide support. The final hui happened last week so now she will collate all feedback into a report and develop a programme of kaupapa and initiatives that the Trust will support.

We are excited to be partnering with Te Puni Kōkiri to deliver "Ngāti Whakaue Māmā - Whai Hua Nui" - an eight-week programme that builds the financial capacity of our Ngāti Whakaue māmā. This is the first time that Te Puni Kōkiri has delivered the programme online, and we are proud to have secured this opportunity for the iwi. We chose our māmā as the target group for this programme for two reasons -

firstly, because they have a key role in managing the finances of the kāinga / household (balancing the cost of kai, school activities, clothes, electricity, heating etc), and secondly, because they also have a role in influencing the financial habits and behaviours of other members of the kāinga. The programme will help our māmā to develop healthy financial habits and make choices on how to achieve their financial goals and aspirations. The programme will also support our māmā to lead kōrero with the rest of the whānau about money matters / take pūtea. The programme runs from March to May, at the end of which the Trust will evaluate the success of the programme and decide whether to deliver more programmes, and whether to expand our target group.

At an investment level (ngā kaupapa haumitanga), the environment remains challenging due to low interest rates and economic uncertainty (highlighted by the recent COVID outbreaks). Our balance sheet is in a healthy position however, and we have capacity to take on quality investments should we find them. Recently we redeployed some of our cash into an iwi owned and controlled commercial property fund, which invests across the motu. The fund is expected to give strong returns on investment, and importantly will provide steady income for the Trust to support our cashflow needs. It is also an opportunity for the Trust to form new iwi partnerships.

Hai whakakapi, we remind everyone to keep safe and not get complacent about COVID-19.

Wharenui Rise Development:

Stage One of the residential development is progressing well as seen in the photo below, and we are on track to have houses being built by the end of this year. NWTL continue to work closely with Iwi, community organisations, local and central government for solutions around Social Housing, Affordable Housing/First Home Buyers, Papakāinga/Kaumātua Housing, General Housing and Retirement Villages. Further updates will be provided as things progress.



Associate Directorship Programme

As the Incorporation grows and diversifies into new areas of business, it is important that we develop the next generation of Directors, and prepare them to govern and manage our taonga tuku iho. In April, we will be seeking applications to select two Associate Directors who will be appointed to one or more of our Boards and Sub-Committees. Keep an eye out on our website and facebook page for information on how to apply.

Grants Initiative:

NWTL continue to provide Health, Tangihanga and Discretionary Grants for owners and the wider Iwi. A whānau trust may now make **two** applications per year, so be sure to apply online or pick up a form from our office. Just a reminder that our financial year runs from 01 July to 30 June.
