#### Museum Bus Grant

In 2010, NWEETB received a request from Rotorua Museum, asking the Board to consider funding to assist with transporting students from decile 1-4 schools in the Rotorua District, to and from the Museum to enable them to attend educational programmes. The request was approved as a one-year pilot programme and 12 years on is still running very successfully. Funding has been increased over time, and now stands at \$20,000 per year (from 2023).

#### **Benefits of the Museum Bus**

Dominique Chandler Rotorua Museum Education Lead | Kaiurungi Mātauranga

The Rotorua Museum Te Whare Taonga o Te Arawa's education team provide authentic, hands – on, minds on, learning experiences to ākonga from Year I through to Year I3, utilising the unique collections, exhibitions, surrounding geothermal environment, and teaching resources of Rotorua Museum Te Whare Taonga o Te Arawa. The programmes weave together The New Zealand Curriculum (NZC) and/or Te Marautanga o Aotearoa as well as key Government priorities to enhance and enrich local curriculum and bring it to life.

Thanks to the very generous funding grant from the Ngāti Whakaue Education Endowment Trust Board, there are no transport/access barriers to learning for local ākonga. All classes from Rotorua Schools are entitled to free transport to and from our programmes via the special museum bus grant funded by the NWEETB. This unique partnership with NWEETB is highly valued by all museum staff and is hugely appreciated by our Rotorua Schools. The museum bus fund allows all classes in Rotorua one free trip per year. Schools who are part of the Child Equity Project (the lowest decile schools in the district) run by Rotorua Lakes Council, are entitled to an additional trip, allowing them two visits per class per year. These schools are targeted with specific marketing to ensure full use of the service.

This year, to date, approximately 2,230 Rotorua students have used the Museum bus to attend the Museum Education Programmes. The opportunities this provides to our tamariki is invaluable.

We thank the Ngāti Whakaue Education Endowment Trust Board for the continued generous support providing funding for the museum bus service. We are extremely grateful to have the opportunity to teach local ākonga through the invaluable service of transport funding provided for our local school children.

Endorsement from local teacher, Dana Haimona, Year 2 Team Leader at Western Heights Primary School - "This term the Year 2 waka at Western Heights Primary School experienced a wonderful session at the Rotorua Library. Our session tied in with our learning about great Te Arawa leaders and the journey of Ihenga. We were so grateful for the free bus service provided by Ngati Whakaue as without this generous service we would not be able to go ahead with trips such as these. Given the nature of our community it can often be difficult to gather enough transport to enable us to get to places to have out of the class experiences and memories for our tamariki. The free museum bus service allows our tamariki to have wonderful experiences and learn about our history, community and country. Without this service we simply would not be able to offer this out of the class education to our tamariki."

Endorsement from local Assistant Principal, Melanie Sweeney, Western Heights Primary School – "I have had the opportunity to attend museum programmes at the library several times throughout this year. On both occasions the Museum Education bus was used as transport for our children. Without this support, we would not have had the same opportunity to attend as our school bus has had multiple issues throughout the year and has been out of action for long periods of time. Our school community is unable to support with transport due to raised petrol costs and generally higher costs of living. Asking our wider school community for transport assistance is not an option. Therefore, having the Museum Education Bus is a great incentive to book programmes for the museum and utilise the facilitators expertise and knowledge to enhance our school programmes. We greatly appreciate the support that Ngati Whakaue provides and would not be able to undertake the same learning experiences for our tamariki without their support."

#### **RINGA RAUTIA - STRENGTHEND BY MANY**

The Trust established a new kaupapa under our distribution goal "Kete Ōhanga - to improve the commercial capability of Ngāti Whakaue pakihi". Ringa Rautia is a 10-week pilot business development programme that includes weekly group workshops, weekly one-on-one business coaching and the opportunity to receive a \$5,000 grant upon completion. In partnership with Toi Ohomai, and with sponsorship from Rotorua NZ, Ngāti Whakaue Education Endowment Trust and Te Puni Kōkiri, Ringa Rautia was designed in response to the needs of our pakihi who are passionate and good at what they do but often need help to build capability in the many other areas of a business ie, accounting and tax, employment and marketing/communications. The key outcome is the development of a comprehensive business plan that the pakihi develop themselves alongside the business coach. Our current rōpū of 11 kaipakihi will complete Ringa Rautia in October 2022. We can't wait to share some of their experiences in the programme with you all.

# NGĀTI WHAKAUE GOVERNANCE ESSENTIALS

Ngāti Whakaue Governance Essentials is a two-day governance literacy course aimed at upskilling our aspiring Ngāti Whakaue governors in the fundamentals of governance from both a western and Ngāti Whakaue perspective. By considering a western and Ngāti Whakaue approach, it is intended that this will support our whanaunga to critically approach governance roles and responsibilities.

Our pilot programme took place in early September and what an incredible wānanga it was - full of whakawhanaungatanga and kōrero. A huge mihi to our Uepū Tohutohu who developed and facilitated the Ngāti Whakaue history, attributes and examples on how we do governance and to Susan Huria who delivered the Institute of Directors Governance Essentials Course.

Part of the programme was an evening function where current Ngāti Whakaue governors attended to network with the participants and share their experiences and insight.

A big mihi to Ngāti Whakaue Education Endowment Trust who helped fund the programme. We are looking forward to continuing to support this rōpū on their governance journeys and are looking to run the next Ngāti Whakaue Governance Wānanga in early 2023.
